SIGN PERMIT INSTRUCTIONS

The following items are needed to obtain a Sign Permit:

1. Site Plan of Property

- Draw to Scale
- Delineate all property lines
- Outline all existing buildings and structure
- Show locations of all existing and proposed signs
- Dimension the building's/unit's frontage and the property's street frontage

2. Elevations

- If mounted on the building, illustrate the signs' positions on the building
- Illustrate the design and dimensions of the proposed signs
- Indicate the type of materials of the proposed sign
- Dimension the height of the sign to the ground

3. Completed Sign Permit Application. (On reverse side)

* Illustrations must accurately depict the position, design and size of the proposed signs.

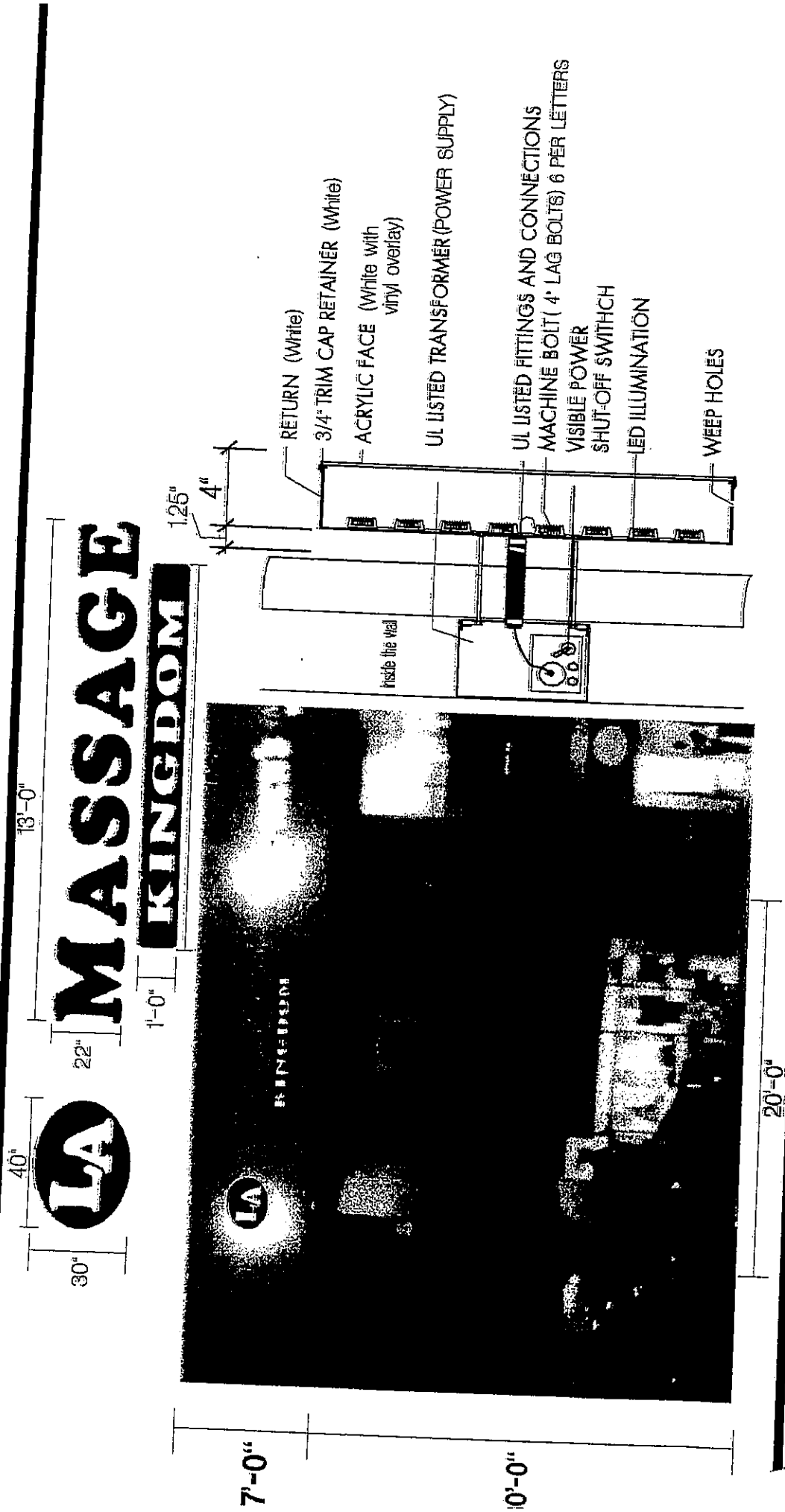
Submit the items listed above to the City's Planning Department to obtain a Sign Permit.

Please Note:

- Any and all new signs for a business, regardless of type size or location, require a Sign Permit prior to its installation or placement.
- Signs screwed into the building or supported by a pole require a Building Permit issued by the Building and Safety Department. Signs painted or glued onto the building do not.
- Illuminated signs require an Electrical Permit.
- Pole Signs and Monument Signs must have engineered footings. Engineering calculations must be provided to the Building and Safety Department for a building permit.

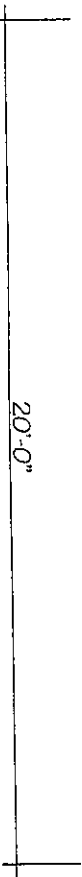

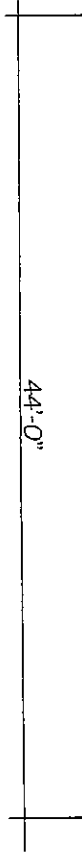
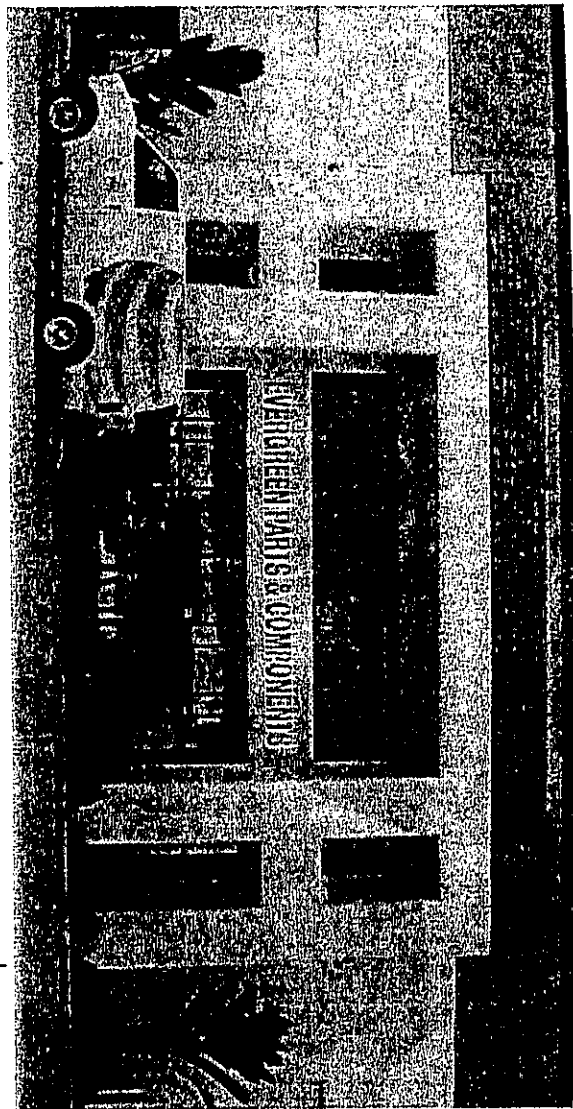
